was launched into the field of sexual violence and healing trauma as a volunteer, professional and activist after surviving being sexually assaulted in 2003. Previously, she was Associate Professor of Emergency Medicine and Public Health at Yale University, serving as Research Director for the Department of Emergency Medicine, and Director of the Yale Center for Public Health Preparedness at the Yale School of Public Health. Lisa is also the Buddhism editor for BellaOnline.com, the largest non-profit women's website on the web, and a writer for Buddha Chick Life, an online women's spirituality magazine. She has a self-paced course offered through DailyOm.com on women's energetics. Lisa is a second-degree black belt in Shotokan karate, a graduate of Sarah Lawrence College, a former Fortune 500 technology executive, and mother to 3 kids and 3 pets. She resides in Los Angeles, CA.

MIEKO FAILEY

Mieko Failey is a Loyola Law School Post Graduate Public Interest Fellow at the L.A. Gay and Lesbian Center, providing legal protection to LGBTQ youth survivors of dating violence, bullying, sexual assault and hate crimes. He retired as a Clinical Professor of Emergency Medicine in June 2011 but maintains a clinical appointment in Emergency Medicine and remains active in clinical forensic medical research both in the Emergency Department and with the Masters program in Forensic Science. Since 1985 he has been a consultant to the California Emergency Management Agency. In 2007 Dr. Green founded and co-chaired the Forensic Medicine Section in the American College of Emergency Physicians (ACEP). Dr. Green was one of the founding faculty members of the Graduate Group in Forensic Sciences that created the Forensic Science Masters Program at UC Davis. His primary research interest is sexual assault, which includes the epidemiology of sexual assault, the forensic medical examination, forensic evidence collection and evaluation, the delivery of sexual assault services, and criminal justice outcomes.

Scheherazade Tillet, MAAT, is the co-founder and executive director of A Long Walk Home, Inc. (ALWH). Since 1998, she has been committed to creating a national platform that speaks out against sexual violence against women and girls. Upon graduating from Tufts University with her B.A. in Child Psychology and a minor in Fine Arts from the School of the Museum of Fine Arts in Boston in 2000, Scheherazade began Story of a Rape Survivor (SOARS), the first of its kind and award winning multi-media performance which intimately examines her sister's healing from sexual assault. In 2003, SOARS became the flagship program for A Long Walk Home, Inc., and Scheherazade has toured SOARS at over 150 colleges and universities. Moreover, Scheherazade's SOARS photographs are featured in two award-winning human rights documentaries, “NO! The Rape Documentary” and “Rape Is...” After establishing her reputation as a young feminist leader through SOARS, Scheherazade earned her Masters in Art Therapy from the prestigious School of the Art Institute of Chicago (SAIC) in 2003. When Scheherazade graduated from SAIC, she began working as an art therapist at Chicago's leading organization to end sexual violence, the YWCA of Metropolitan Chicago. Scheherazade was the only rape crisis counselor in the Westside of Chicago, serving neighborhoods that have the third highest sexual assaults and homicide rates in Illinois.

SARAH TOFTE
